

MINUTES OF THE EDAS AGM HELD THURSDAY, 14^{TH} DECEMBER 2019, AT BURNESS PAULL, EDINBURGH

Robert Pollock, Chair of EDAS, welcomed all present.

Stephen Phillips welcomed guests to Burness Paull and acknowledged the positive space provided by EDAS for discussion. He noted that there are three key areas of focus to consider within economic development in Scotland namely wellbeing economics, uncertainty with Brexit and climate change and the growth of partnership working across public, private and the third sectors.

EDAS AGM Business

The Minutes of the 2018 AGM, as well as the Financial Accounts for Year to end 31 March 2019 are available in the Publications area of <u>our website</u>.

1. To consider and approve Financial Accounts for Year to end 31 March 2019.

As required by the Companies Act 2006, a copy of accounts has been made available on our website and offered to members on request.

Financial Statement:

"The organisation had a surplus in year of £14,468 (2018: £2,902). The surplus arose on unrestricted reserves, there was no surplus or deficit on restricted reserves (2018:0).

In relation to reserves, the trustees have considered that the ideal level of unrestricted reserves would be sufficient to cover six months operating costs. EDAS has taken the opportunity during the year to further strengthen its reserves position and they now stand at £53,258 (2018: £38,790) and the trustees are of the opinion that this is sufficient for the organisation.

The charity does not hold any investments. Any surplus cash flow during the year is reinvested in pursuit of the charity's aims and objectives.

The trustees have considered the major strategic business operational risks which the company faces and are in the process of developing systems to ensure that risks to the charity are minimised."

The accounts were accepted.

2. To Consider and Appoint Accountants, Soroban, for the next year.

Members' approval was sought to consider and appoint accountants, Soroban for the next year. Soroban's continued appointment was accepted.

3. Election of Directors

Members' approval of the following appointments was accepted.

- Ishabel Bremner, Argyll and Bute Council and Charlie Woods, Scottish Universities Insight Institute, are both co-opted Directors and as such shall retire from office at the AGM but shall then be eligible for re-appointment under article 81, both have agreed to this.
- Elected Directors required to retire by rotation under articles 69 74:

- Appointed since last AGM:
 - o Linda Christie
- Resigned as Directors during the year were David Baxter and Hazel Mackie.

This concluded the formal aspects of the EDAS AGM 2019.

In closing the formalities, Robert Pollock highlighted the strength of EDAS membership and service offering - events, CPD (Inclusive Growth, Introduction to Economic Development, Appraisal Monitoring and Evaluation with an Advanced version of the latter taking place in the New Year.), policy, quarterly parliamentary briefing, networking opportunities. 
